7. General Requirements:
 - Lockers must comply with **IS 5244:2011** (Indian standard for safe deposit lockers)
 - Lockers should be suitable for installation in a strong room/secure vault.
 - Design must ensure security durability, fire resistance and aesthetic appeal.
 - Manufacturer must be ISO certified and have prior experience supplying lockers to Banks/Financial Institutions.

Material	High quality cold rolled steel or equivalent.
Finish	Powder – coated or epoxy coated, corrosion resistant, scratch resistant.
Doors	Reinforced doors with over lapping construction to prevent Prying minimum 2mm thickness.
Compartments	Combination of Medium (35 cabinets) +Big (15 cabinets) arranged in uniform rows/columns. Big size lockers
Reinforcement	All doors must have reinforced backs for added strength
Locking Mechanism	Dual control locking system: One key retained by the customers and one by the bank. Each lock must be tested and certified for quality and performance.
Accessories and Labeling	Lockers to be numbers using permanent, engraved number plates. Each locker to include an ID card tag, inner box/safe and key pouch.
Testing	All lockers must be factory tested and certified.

Warranty	Minimum 2 years warranty from date of installation, Free onsite service during warranty period.

8. Installation :

- Supplier must install lockers securely at the designed site.
- Must provide installation drawing, leveling anchoring and alignment.
- All installation work must be carried out by trained technicians.
- Final sign off only after successful inspection by the bank.
