ELIGIBILITY CRITERIA FOR HRMS & PAYROLL SYSTEM
TO DCCB MAHABUBNAGAR.

Applicants must carefully read the eligibility criteria provided and proposals of only those Applicants who satisfy these conditions will be considered for evaluation process. To be eligible for evaluation of its Proposal, the Applicants have to fulfil the eligibility criteria given below.

1. The Eligibility Criteria will apply to the Bidder, should have neither failed to perform any agreement during the last three years, as evidenced by imposition of a penalty by an arbitral or a judicial pronouncement or arbitration awarded against the Applicant, nor been expelled from any project or agreement nor had any agreement terminated for breach by such Applicant.
2. The bidder must be registered under Indian Companies Act 1956 and having IT Operations for minimum period of 5 Years. Certified copy of the Certificate of Incorporation issued by the Registrar of Companies and Certificate of Commencement of business issued by the Registrar of Companies to be closed.
3. Bidder must have its own valid PAN No. and GST Registration No. TIN & CIN.
4. During last 3 (Three) years the bidder should not have been black listed from participating in bid by Govt/other Organization. An undertaking to this effect is to be submitted by the bidders. If subsequently the bidder's under taking is found

- to be incorrect the tender/order if placed on the bidder with reference to this tender shall be cancelled.
5. Bidder should have successfully completed the implementation of HRMS & Payroll solution in Banks /Financial Institutions /Insurance Companies/PSU/ Government Organizations in the last 3 years, and implemented at least in one APEX Bank and in one District Central Co-op. Bank of State Co-op. Bank.
 6. Average Annual financial turnover during the last 3 years ending 31st March of 2026 should not be less than 25 Crores.
 7. The Bidder should be an ISO 9001, ISO 27001 and CMMI Level 3 certified company.
 8. The Bidder should have a Head office or branch office in Telangana.
 9. The bidder should be a software vendor for ~~telangana~~ state apex bank or DCCBs during last three years.
